- a) **Receives the report titled "Stewart Island / Rakiura Visitor Levy Fund Financial Report and Application Summary - March 2018" dated 23 May 2018.**
- b) **Approve the allocation of funds for the Stewart Island / Rakiura Visitor Levy Fund as follows:**
 1. **Department of Conservation – Development of Observation Rock viewing platform \$80,000, with \$10,000 (plans and consents) to be available for immediate uplift, and the balance of \$70,000 when the work can be guaranteed to progress.**
 2. **Rakiura Heritage Centre Trust - \$22,500 towards museum development costs.**
 3. **Rakiura Heritage Trust - \$800 for Historical Walkabout pamphlet**
 4. **Stewart Island Promotion Association - \$1658 for the printing of the Stewart Island street map.**
 5. **Stewart Island Promotion Association - \$2849 for the installation of wifi**
 6. **Stewart Island/Rakiura Community and Environment Trust (SIRCET) – \$5,000 for vehicle replacement.**
 7. **Stewart Island/Rakiura Community and Environment Trust (SIRCET) – \$5,000 for habitat restoration.**
 8. **Stewart Island/Rakiura Community Board - \$0 for the Horseshoe Bay Road footpath**
