The Board was advised the purpose of the report is to provide an overview of key issues across the Southland District, as well as high level local issues from various Council units.

Members noted the report highlighted various issues of interest including:

 Members were informed New Zealand's population make-up is changing, and
 population growth is largely in the North Island with Southland predicted to remain
 largely static in the next 20 years.

The Community Partnership Leader advised the annual survey of local authority progress towards the implementation of the earthquake prone amendments to the Building Act which took effect from mid-2017 has been completed.

Members were advised of buildings within the medium and low risk zone noting Winton is an area with a higher number of unreinforced masonry buildings.

 The Meeting noted the road design for the District wide pavement programme for 2019/2020 season is currently being completed with the first tender on track for being released to market around mid-July.

9.1 Chairperson's Report

Chairperson Somerville reported on matters with which he has been involved since the Board's last meeting, these included:

 request from Township gardener for purchase of two hundred trees for the Moore's reserve walking track area. Members noted quotes were received from Home Creek and Fiordland Nursery at a total cost of \$906.60 (plus GST).

Following discussion the Board agreed to the purchase of the plantings at a cost of \$906.60 (plus GST) to be funded from the Winton Parks and Reserves budget.

- a) Agrees to purchase up to two hundred trees for the Moore's Reserve walking track from both Home Creek Nursery and Fiordland Nursery at a total of \$906.60 (excl GST) to be funded from the Winton Parks and Reserves budget.
- b) Agrees to support the Winton Rotary Club request to extend the walking track along the creek from Hilary Street to the Reserve Car park at a cost of \$6,900 (excl GST) to be funded from the Winton track maintenance budget.

9.2 Councillor's Report

Councillor Paterson expressed concern at lack of cell coverage in areas and slowness of the internet connection advising that he has been in contact with providers seeking responses.
