1 Apologies

2 Making and Attesting of Members' Declarations

Moved Denise Fodie, seconded Pani Grey-Thomas that the Waihopai Toetoe Community Board agrees that the election of a Board member as the Deputy Chair be held over until the February 2020 meeting. The motion was put and declared CARRIED.

 - (ii) Requests that the business unit 27850 – Tokanui Hall general maintenance budget ensure that there is an allowance for the borer control of approximately \$400 and note that this will have an impact on rates.
 - (iii) Request that the Tokanui business units be clarified for Ward contribution and overall impact on rates and amended accordingly.
- e) Recommends to Council the setting of the following rates and charges (including GST) for the year commencing 1 July 2020 based on the approved budgets in (d) above with a change to the Edendale/Wyndham Community Board Rate.
