Community Facilities Asset Management Officer - Colin Pemberton was in attendance for this item.

Mr Pemberton advised the purpose of the report is to request unbudgeted expenditure of \$19,500.00 to connect the Clifden hall to the Otahu Flat water scheme, and undertake remedial work to the Hall prior to repainting the exterior of the hall.

Following discussion the meeting agreed to unbudgeted expenditure of up to \$20,000 (excl GST) for the water connection to the Otahu Flat Water Scheme and associated works to create that connection and further requested staff investigate alternative management options for the Clifden Hall.
