#### **6 CHAIRPERSON'S REPORT**

MR KEITH THOMPSON PRESENTED THE CHAIRMAN'S TRIENNIAL REPORT 2017-2021 TO THE MEETING.

MR THOMPSON COVERED THE FOLLOWING ISSUES:

- INFRASTRUCTURE SPENDING RESERVOIR TANKS HAVE BEEN RENEWED ON THE KAKAPO AND MT YORK SCHEMES AND THE RISING MAIN AND RESERVOIR WERE RENEWED ON THE HOMESTEAD SCHEME. PIPELINES UPGRADED AS NECESSARY AND IT WILL BE A CONSTANT REQUIREMENT IN THE FUTURE AS THE WATER SCHEMES AGES
- URGENT AREAS OF CONCERN ARE THE RISING MAIN ON KAKAPO SCHEME AND THE CONFIGURATION AND AGE OF THE PIPEWORK ON THE MT YORK SCHEME
- FULLY SUPPORT USING AN APP TO ALERT CONSUMERS OF PUMP OUTAGES OR OTHER PROBLEMS



- CONCERNED THAT REGULAR PREVENTATIVE MAINTENANCE THAT SHOULD BE PART OF DOWNERS CONTRACT IS NOT BEING DONE
- CONSENT RENEWALS FOR RAMPARTS, KAKAPO, HOMESTEAD AND PRINCHESTER ARE BEING FINALIZED AT PRESENT. COST FROM ENVIRONMENT SOUTHLAND SEEMS EXCESS WITH NO ACCOUNTABILITY TO THE RATEPAYERS.
- THE UNKNOWN FOR THE FUTURE WITH THE THREE WATERS REFORM PROGRAMME
- ACKNOWLEDGED THE WORK OF COUNCIL STAFF, DOWNERS AND MEMBERS FOR THE PAST TERM.
