The Board at their meeting in August 2021 agreed to lie the report on the table to enable members of the Pool Committee speak at a meeting to answer questions prior to a decision being made in relation to the Pool Committee request to increase the pool rate. This request would need to be a recommendation to Council via the Annual Plan process.
