1 Apologies

There were apologies for absence from Gay Munro.

Moved Chairperson Yorke, seconded Melanie Shepherd and resolved:

That the Waihopai Toetoe Community Board accept the apology.

Reports

7.1 Community update

Malcolm Peacey – Senior environmental manager, Fonterra Co-operative Group Limited – Malcolm Peacey was in attendance.

Mr Peacey gave an overview of the Fonterra Edendale 2021/2022 season.

He highlighted that:

- the drought had reduced milk volumes through March and April but overall the amounts were very similar over the season
- Covid 19 has caused some disruption to the site but all milk was managed to be processed with a few adjustments to product mix
- the site is tracking well on the waste to landfill and coat use of both being down significantly compared to the 2020/2021 season
- an update to the stormwater divert and containment system is currently being upgraded to enable quicker response to spills and reduced reliance on contractors.

Other items to note at Fonterra Edendale are:

- best site award for productivity and depot driver performance
- irrigation has finished for the season with around 200-500 kilograms of nitrogen per hectare has been applied to Fonterra land through wastewater and fertiliser
- the aquifer has been lower than normal through summer and autumn and is starting to recharge
- noise monitoring at the new tanker entrance to the Edendale site is showing technical compliance with tanker movements
- community grants have been received by various groups over the season

(During discussion, Pani Grey-Thomas joined the meeting at 7.04pm.)

- 7.2 Building Disposal Seaward Downs Recreation Reserve

Property advisor - Theresa Cavanagh was in attendance for this item.

Ms Cavanagh advised that the purpose of the report was for the Board to agree to recommend to Council that the Seaward Downs School building is surplus to requirements and be disposed of.

The Board noted that the building is a former school and is located at 710 Edendale Seaward Downs Road. It was built in 1891 on another site and relocated to the current site



in 1954. In 1983, the property was vested in the Southland County Council in trust for a recreation reserve.

Following discussion on the disposal the Board requested that the Seaward Downs Domain Committee report to the Board on the clearing up of the site when the building has been removed.

Resolution

Moved Deputy Chairperson Fodie, seconded George Stevenson recommendations a to d and a new e <u>as indicated</u> and resolved:

That the Waihopai Toetoe Community Board:

- a) **receives the report titled "Building Disposal** Seaward Downs Recreation **Reserve" dated** 20 June 2022.
- b) determines that this matter or decision be recognised as not significant in terms of Section 76 of the Local Government Act 2002.
- c) determines that it has complied with the decision-making provisions of the Local Government Act 2002 to the extent necessary in relation to this decision; and in accordance with Section 79 of the act determines that it does not require further information, further assessment of options or further analysis of costs and benefits or advantages and disadvantages prior to making a decision on this matter.
- d) agrees to recommends to Council that the Seaward Downs School building is surplus to requirements and be disposed of.

New e) requests that the Seaward Downs Domain Committee report to the Board on the clearing up of the site when the building has been removed.

7.3 Wyndham hall kitchen upgrade - Retrospective unbudgeted expenditure

Community facilities manager – Mark Day was in attendance for this item.

Mr Day advised that the purpose of the report was to seek approval for retrospective unbudgeted expenditure of up to \$15,000 to cover the additional costs for out of scope items requested by the Waihopai Toetoe Community Board to be funded from the Edendale Wyndham Community Centre reserve.

The Board noted that as the project progressed the requested changes to the original scope of works had resulted in additional costs to the project which were as follows:

• purchase and installation of a new oven (the original scope was to use the two existing ovens), an extractor fan over the oven, dish steriliser and additional roller door from the supper room (two doors allowed for in the original scope).

- f) approves a grant of \$1,600 to the Seaward Downs Community Centre for assistance towards maintenance work on the Seaward Downs war memorial to be topped up by the board should be unsuccessful in obtaining other funding.
- g) approves a grant of \$300 to the Edendale Netball Club for assistance towards purchasing new equipment for the club.
- h) approves a grant of \$2,640 to the Menzies College PTA for assistance towards costs to implement a community garden.
