# 7.2 Proposed Regional Climate Change Strategy consultation

This letter was not received directly by the Chair and as a result was not responded to as it had been received via the Southland District Council "general" email address. It was forward to the Mayor and Waihopai Toetoe Ward Councillors.

Chair Yorke became aware of the letter when there was a response from the Mayor to Mrs Stewart. The letter was acknowledged at the Board's meeting in December 2023 and that the Board were happy with the response from the Mayor.

A subsequent letter was received asking for a reply to the December 2023 letter. Chair Yorke advised that a response would be arranged.
