## Reports

### 6.1 Oraka Aparima Community Board recommendation to locate giant paua shell to Koi Koi Park

#### Purpose

Community partnership lead, Stella O'Connor explained that the purpose of this report was to seek recommendation from the Oraka Aparima Community Board to locate the newly refurbished giant paua shell to Koi Koi Park, which is endowment land.

#### Resolution

Moved Chairperson Weusten, seconded Deputy chairperson Linscott **and resolved:**

#### **That the Oraka Aparima Community Board:**

- a) **Receives the report titled "Oraka Aparima Community Board recommendation to locate giant paua shell to Koi Koi Park".**

## 6.2 Investigation into renaming of Koi Koi Park to Kohikohi Park

**Record No: R/24/5/31518**

Community partnership lead, Stella O'Connor explained that the purpose of this report was to seek a recommendation from the Oraka Aparima Community Board on whether it wishes to support the further investigation and potential change of spelling of the park name known as Koi Koi Park to Kohikohi Park in Riverton.

A recommendation for support has been given from the Riverton Harbour Subcommittee for the investigation and potential change of the spelling on park signage and any other reference that has Koi Koi spelling (for example the SDC website).

Council will need to approve the change of spelling of Koi Koi Park to Kohikohi Park.
