KAREN PURDUE (COMMUNITY PARTNERSHIP LEADER) WAS IN ATTENDANCE FOR THIS REPORT.

MRS PURDUE AMENDED TWO POINT IN THE REPORT – PAGE 17 SHOULD READ "ACCOUNTABILITY FOR THE 2022 GRANT HAS NOT BEEN PROVIDED". THIS IS BECAUSE THIS PROJECT HAS NOT YET BEEN COMPLETED. ALSO THE RAKIURA HERITAGE TRUST ACCOUNTABILITY RETURN (PAGE 19) HAS NOW BEEN LOCATED.

THE SOUTHLAND DISTRICT COUNCIL STEWART ISLAND/RAKIURA VISITOR LEVY FUND IS AVAILABLE TO GROUPS AND ORGANISATIONS TO ASSIST WITH PROJECTS, ACTIVITIES AND/OR SERVICES USED BY VISITORS; FOR THE BENEFIT OF VISITORS; OR TO MITIGATE THE ADVERSE EFFECTS OF VISITORS ON THE ENVIRONMENT OF THE ISLAND.

THERE IS ONE FUNDING ROUND PER YEAR. CLOSING ON THE SECOND FRIDAY OF MAY.

THE FINANCIAL REPORT AS AT 30 APRIL 2024 AND SUMMARY OF APPLICATIONS RECEIVED FOR CONSIDERATION FOR THIS FUNDING ROUND, ARE CONTAINED IN THE REPORT FOR REVIEW AND APPROVAL. COMMITTEE MEMBERS HAVE BEEN GIVEN COPIES OF THE FULL APPLICATIONS PRIOR TO THIS MEETING.

THERE IS \$273,305 BUDGETED FOR GRANTS THIS FINANCIAL YEAR, AND \$441,518 IN TOTAL AVAILABLE IN RESERVES TO DISTRIBUTE.

A TOTAL OF FIVE APPLICATIONS HAVE BEEN RECEIVED, WITH REQUESTS TOTALLING \$266,822 FOR THIS FINANCIAL YEAR, AND \$34,688 IN THE NEXT FINANCIAL YEAR AS ONE APPLICANT HAS A MULTI-YEAR REQUEST.
