General Overview

It is always a busy time heading towards the end of a calendar year. Over the last few weeks, since we had our last JSC meeting, concentration has been to work with the shareholders to develop the next Letter of Expectation. To date, the GMs and I have presented to Invercargill City Council, Gore District Council and Southland District Council.

Some of the key highlights since the last JSC meeting:

• Great South hosted 17 delegates for the Regional EDA Primary Sector Collaboration project. Funded by the Agricultural and Marketing Research and Development Trust (AGMARDT), we hosted representatives from Northland Inc, Venture Taranaki and Venture Timaru in our region. It was a great chance to not only showcase our innovative and forward-thinking region, but to also look at alignment on some key things that we all overlap with e.g. how we are approaching the Government's target of doubling exports. We were thrilled to have Thriving Southland included as part of the collaboration as a key stakeholder from Murihiku Southland.

We were well supported by our stakeholders, who presented to the visiting EDAs. This included: Invercargill Airport; South Port; Thriving Southland; Southland Dairy Hub; Invercargill Central Ltd; Ocean Beach hub (x5); Stewart Island/Rakiura Community Board and Councillor Jon Spraggon; Space Operations/Awarua Tracking Station staff; Southland Youth Futures team and Great South's RBP team. A very special thankyou goes out to Mayor Rob Scott who opened the event on behalf of our shareholders.

The EDAs were "blown away" with what we are up to down here. We come across as a region which has a clear plan and is successfully implementing in a collaborative manner.

• The Economic Development New Zealand (EDNZ) Conference was held in Dunedin between 23 & 24 October. This conference is a major event for our business and where we undertake professional development. The shareholders may recall that last year Great South won the Best Integrated Strategy Award for Beyond 2025 at the EDNZ awards night. Although we didn't submit an application for awards for this year, the Regional EDA Primary Sector Collaboration project won highly commendable for the work we are collaborating on. I will show a short video on the project at the next JSC meeting.

The EDNZ conference was themed 'Tech-Led Economic Development: Enhancing Productivity for New Zealand's Future'. There were some great speakers touching on technology to build and grow productivity and efficiencies. Artificial intelligence (AI) featured a lot during the presentations. Insights from some thought-provoking businesses that comprehensively use AI to enhance and support their services, was intriguing.

 I was present at the Mayoral Forum meeting that hosted Hon Simeon Brown, in his capacity as Minister for Local Government, Transport and Energy. Mayor Rob Scott presented to Minister Brown, highlighting

the importance of our roading network, which is the second largest in the country as the lifeline of our economy. A request was made to the Minister to enable Southland to get its fair share of investment to upgrade our roads and weight restricted bridges and support the government's target to double exports over the next 10 years.

- On 31 October, Steve and I presented to Australian High Commissioner, Her Excellency Harinder Sidhu
 and spoke about our regional opportunities and initiatives that are being progressed. This included
 aquaculture, housing, decarbonisation and the energy strategy and space operations. The meeting was
 productive, and a good foundational relationship was established with the High Commissioner.
- As advised at the last meeting, I am honoured to be part of the Small Business Advisory Group that Minister Bayly has now created. I travelled up to Auckland to attend the first meeting on 04 November 2023, and it was great to represent Southland alongside Sheree Carey from the Southland Business Chamber. The group's terms of reference and objectives will be clarified over the next few weeks. When Minister Bayly addressed the group, it was clear that we needed to identify how our regional businesses could support the government's ambition to double exports.

This initial meeting also touched on Cyber Security and AI and how we can ease compliance burdens for businesses.

- I have continued to support MBIE to organise the Murihiku Regional Summit which is scheduled for Friday this week. We have close to 130 attendees confirmed and speakers are all lined up now. Only two sectors will be presented on aquaculture and energy. I will give a quick overview of Southland, our opportunities and will show the 'Get A Life" video on the day of the summit. Bobbi will make a quick presentation on aquaculture for the region.
- Hon Shane Jones will be opening the Combined Community Trusts biennial conference and will also be
 visiting a few businesses while he is here in Murihiku Southland. There is a tour of Ocean Beach with
 media coverage, which I will be part of.
- Tuesday 12 November will be a busy day for Great South. We have our AGM in the morning, Board
 meeting thereafter and then at 4pm, we will be launching DISH. We look forward to engaging with you,
 your staff and/or representatives.
- We understand that with Combined Community Trusts biennial conference is being held in Invercargill
 between 12 -14 November so a followed by the Murihiku Regional Summit, it's a busy week for our
 shareholders as well.

On a final note, I would like to acknowledge Reece McDonald and his position as President of the Southland Business Chamber. It was a difficult week following Reece's untimely and premature death, Southland reeled from his tragic demise. Reece was a well loved and much respected member of our community. As we all gathered to pay our last respects, it was evident that the loss of Reece would be felt for a long, long time. Although Reece was the President of the Chamber for only a short time, we appreciated the opportunities he afforded to Great South.

We would also like to acknowledge and congratulate Chris Hughes on being nominated as the new President of the Southland Business Chamber.
