7.1 Community update

Britt Mathias (Department of Conservation updated the board on the following topics:

- continuing rat incursions, Ulva Island
- Predator Free Rakiura community consultations are ongoing
- there are five new holho chicks on Bravo Island
- more penguins have been spotted on local beaches, coming ashore for the moult
- there has been a downturn of 18% trampers on Stewart Island tracks this season. This decrease is in both domestic and international users.
- repairs and maintenance have been carried out at Freshwater, Tolsons and the bolts have been tightened under the Observation Rock viewing platform

- sealion warning signs have been installed on Ulva Island and around the township. These will be in place for the season only.
- · consideration is still being given to gravelling parts of the Rakiura track
- some gravelling has been carried out on Ulva Island, undertaken by volunteers

- parking restrictions these will be enforced once the signage is in place. It would be good to advertise these changes widely.
- paradise ducks are becoming a problem in Halfmoon Bay

- the Golden Bay masterplan is still awaiting feedback from Te O Marama
- · current de-sludging work at the waste treatment station is encountering issues
- are the flexible marker posts (especially at Golden Bay) necessary, as they are very often broken?

7.4 Unbudgeted expenditure - roading bylaw signs

Record No: R/25/2/3871

Ben Whelan (Roading engineer) was present for this item.

This report seeks the board's endorsement for an unbudgeted expenditure of \$33,337 to install signage associated with the amended Roading Bylaw across the Stewart Island network. Following a comprehensive review of the current Roading Bylaw restrictions and subsequent public consultation in October 2024, Council adopted the amended Bylaw on 11 December 2024. The amendments focus on new parking restrictions and a one-way system to better manage parking access issues and enhance road safety around Observation Rock.

The new bylaw restrictions will necessitate the installation of 65 new signs and associated posts. As these works are not included in the Long Term Plan (LTP), staff are requesting the board's endorsement for the unbudgeted expenditure of \$33,337 by way of a locally funded loan. These works will include supply and installation.

Resolution

That the Stewart Island/Rakiura Community Board:

- b) determines that this matter or decision be recognized not significant in terms of Section 76 of the Local Government Act 2002.



- c) determines that it has complied with the decision-making provisions of the Local Government Act 2002 to the extent necessary in relation to this decision; and in accordance with Section 79 of the act determines that it does not require further information, further assessment of options or further analysis of costs and benefits or advantages and disadvantages prior to making a decision on this matter.
- d) recommends to Council the approval of unbudgeted expenditure of \$33,337 toward the supply and installation of new signage relating to the 2024 Roading Bylaw amendment, to be funded by a 15 10 year loan to be repaid from the Stewart Island/ Rakiura Community Board rate.

7.5 Chairperson's report

The following items were discussed by board members:

Energy – currently awaiting the funding application response

Power loss – Unaccounted for power loss is being investigated by Hartley Hare and also the energy pilot group

Ulva Island wharf – a decision needs to be made to either accept the Hunter family proposal or renew the wharf on the current footprint. All previous work and reports have been reviewed. A scope of work required for upgrading the original wharf needs to come from Emtech. Possibly an upgrade might be possible in October 2025. The work would need to proceed under the existing resource consent conditions. Until a plan is prepared it would be difficult to ascertain whether the upgrade would be considered to be repairs and maintenance. Current thinking is to upgrade the wharf in a heritage style with the improvements of ramp access.

The board requests full costing and plans for the April community board meeting. An individual Ulva Island wharf user fee needs to be considered in conjunction with the current wharf user licence,

The current uncertainty is affecting the tourism numbers and causing anxiety for operators. The situation for private/tourism operator access is not yet clear. Dialogue needs to be kept open with the Hunter family.

Golden Bay walking track – currently with WSP who will be drilling for soil samples. The plan is for a two metre wide boardwalk manufactured from fibre reinforced material. The concept designs are back from the engineers, and once the geotech results are back, a concept plan can be confirmed

Predator Free Rakiura (PDF) – at the engagement meeting yesterday it was announced that the trial area at Pegasus is now on hold. Instead a suppression activity will take place in a dotterel area (DOC funded) which will include deer repellent and rat action. PDF are funding monitoring of this trial.

The community meeting held 10 February was discussing 1080 (two sessions, four speakers). It was suggested that going forward a clearer idea of each meeting's agenda be given, along with future dates. It is hoped that communications about meetings will improve. Toxins and bio-security are the hottest topics, and someone should always be available at the community meetings to cover these.

Roading reserve gardens – a short discussion took place about the unattended garden plots past the museum on Main Road. Jacqui will be on island on 24 February and the future of these areas will be discussed then

Recycling and green waste review – Evidently this is progressing behind the scenes. Grant Isaac will meet with Cr Jon Spraggon and Chairperson Aaron Conner.

Spatial planning – an update went to Council yesterday. Stewart Island's planning will take place between March and May 2025.

Emergency management plan – Janelle Ladbrook has forwarded the incomplete updated plan to Aaron Joy for further work

proposed council amalgamation – the proposal has been referred to Wellington **smart meeting training** – there have been some issues with import/export meters, which are being followed up by staff

dog enforcement – there seems to be a lack of action on this, and some confusions as to the whereabouts of the pound
